6.1	<b>Steps to be taken in case material is Spilled or Released:</b>	Evacuate all non-essential personnel. Stop source of spill as soon as possible and notify appropriate personnel.
6.1.1	<b>Air Release:</b>	Vapors may be suppressed by the use of a water fog or spray. Contain all liquid for treatment or neutralization.
